



12K'S OF CHRISTMAS: GIVEAWAYS RULES & REGULATIONS

Overall Guidelines:

(incorporated in 1994) is a not for profit organization whose mission is to encourage individuals and families to adopt and maintain a healthy and active lifestyle. The organization promotes fitness to all ages and all abilities through community running events, school based programs and community collaborations
- Sweepstakes prizes do not require registration for the 12Ks of Christmas - see each contest for specific guidelines
- Registration for the 12Ks of Christmas or any other Hartford Marathon Foundation event do not enhance your chance of winning

- Winners will be selected after the conclusion of the 12Ks of Christmas Challenge on Saturday, December 12th, during the week of December 14th
- Void where prohibited by law and outside of the United States of America
- Entries will be accepted online starting at 12:00 AM, Monday, November 9th, 2020 EST and ending 11:59 PM Sunday, December 14th, 2020 EST. All online entries must be received by 11:59 PM, Sunday, December 14th, 2020 EST.
- Winners are eligible to receive multiple prizes
- All winners will be selected at random, no judging criteria will be used
- Liability limitations
- Odds of winning will vary during each contest
- Winners must provide a physical address, P.O. Boxes will not be acceptable.

The 12Ks of Christmas Giveaway is only open to legal residents of the United States of America, and is void where prohibited by law. Employees of Hartford Marathon Foundation, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the 12Ks of Christmas Giveaway. The 12Ks of Christmas Giveaway is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

In addition, You agree to accept the decisions of Hartford Marathon Foundation as final and binding as it relates to the content of this 12Ks of Christmas Giveaway.

3. 12Ks of Christmas Giveaway Period: Entries will be accepted online starting on 12:00 AM, Monday, November 9th, 2020 EST and ending 11:59 PM Sunday, December 14th, 2020 EST. All online entries must be received by 11:59 PM, Sunday, December 14th, 2020 EST.

4. How to Enter: The 12Ks of Christmas Giveaway must be entered by submitting an entry using the guidelines given for the 12Ks of Christmas Giveaways. The entry must fulfill all 12Ks of Christmas Giveaway daily requirement, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Hartford Marathon Foundation. You may enter only once for each prize. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. Winner will be notified by email or phone within five (5) days following selection of Winner. Hartford Marathon Foundation shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 10 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this 12Ks of Christmas Giveaway is conditioned upon compliance with any and all federal, state, and local laws and regulations. In such case, Hartford Marathon Foundation may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Hartford Marathon Foundation. Hartford Marathon Foundation reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the 12Ks of Christmas Giveaway or website or violates these Terms & Conditions.
